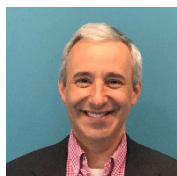

Ms. Howell, Health Commissioner for Greene County, is a well-known and distinguished public health leader. She is known for consistently translating vision to action and curriculum development. Ms. Howell has a long history of forging coalitions in unique and inventive ways, to bring about change and amplify the impact initiatives have on the health and well-being of a community. She has been a registered nurse for thirty-two years and REHS for eleven years.

Working with other organizations, Ms. Howell's efforts helped secure the first Federally Qualified Health Center for Greene County, achieve accreditation in two health districts, and construct a facility to provide medical and public health services. She founded a coalition to educate nursing students in emergencies, developed and taught leadership and management and financial skills to public health professionals in Ohio. Twice she has been involved with a cooperative program with the Ohio National Guard called GuardCare.
